## a) Pier 5 to 7 Redevelopment - update

- Staff attended Hamilton Waterfront Redevelopment subcommittee meetings (Chaired by J. Farr) of City Council on September 9 and October 22. No changes to the redevelopment of Piers 5 to 7 were made but the subcommittee recommended a relocation of budget allocations to fund the proposed works on Piers 5 to 7. The Plans for Pier 6 & 7 did not change.
- This redevelopment will add some 950m of new publicly accessible shoreline.
- A number of future development plans/components in the area west of Pier 5 were modified.
- W. Plessl met with Collective Arts to discuss possible use of the Pier 8 lands for events to bring people to the waterfront.
- City hopes to time pieces of development to expedite temporary animation while construction is underway.
